# Special Religious Education (SRE) Combined Arrangements Sample Form 2018

## **Combined arrangements** From Department of Education Revised Special Religious Education Procedures (November 2017 p. 8)

Combined arrangements occur in some schools in the delivery of SRE. Religious persuasions may decide to provide a combined arrangement for several reasons, including human resource management. No religious persuasion should be compelled to participate in this form of organisation.

In combined arrangements, each religious persuasion must be an approved provider. The curriculum and the SRE teacher, must be authorised by at least one of the approved providers. The approved providers must clearly identify to the school which approved provider is responsible for authorising the curriculum and the appropriate website link.

In a combined arrangement, only those students whose parents/caregivers have nominated one of the participating religious persuasions are to be included. A combined arrangement should be reviewed periodically by the school and the approved providers involved.

# Instructions for completing this form (one required for each individual school)

In both Primary & High Schools where one or more churches combine to teach students from different churches, (even if those children/youth don't attend but may have a specific church or 'Christian' listed on their enrolment form) a Combined Arrangements Form needs to be supplied to the school when SRE commences each year. This applies even if all the teachers come from one church.

The first table lists all the local churches and the Approved Provider they come under. (Only teachers authorised by an Approved Provider can teach SRE.) The clergy/leader from each local church sign the form to say that their church is part of the combined SRE arrangements. The clergy listed in Table 1, by signing the form are cross authorising all the teachers listed in Table 2 to teach on their behalf. The teachers don't need to sign the form.

**Approved Provider:** This is the 'umbrella' organisation listed on the **Government Approved Provider list** of those approved to teach SRE. Approved Providers are usually denominations, groups of churches of the one persuasion, but some independent churches are included. Those who are represented in the area (by a local church) are listed in column one of Table 1. They include churches that don't supply teachers because there may be some children who list their denomination/religion as belonging to them.

**Individual church/group** This is the name of the local church. In the case of an independent church on the Approved Providers list, it will be the same as in column one.

Signature of Local Clergy/Leader: This should be the Minister/Leader of the local church near the school (listed in column 2).

The second table is a list of all the SRE teachers: their full name, date of birth, church they attend, minister/leader who is responsible for the named SRE Teacher and contact phone number of the church of minister/leader.

The statement below is an assurance that the SRE Teacher's WWCC cleared number has been verified and they have been authorised by an Approved Provider and fulfil the requirement of the NSW Department of Education.

The agreed curriculum(s) to be used must be included on this form and by signing, the clergy are authorising that curriculum.
